

Collecting Data on the Impact of the COVID-19 Pandemic on our Transplant and Cell Therapy Recipients

ANNOUNCEMENT

In an effort to collect data on the impact of the COVID-19 pandemic on our transplant and cell therapy recipients, CIBMTR is making a number of alterations to our data collection forms to facilitate collection of these data.

Change effective Friday, March 27th, 2020 (9PM CST)

CRF/CT Track Reporting: The Post-HCT Follow-up Data Form (2100) and Cellular Therapy Essential Data Follow-up Data Form (4100) will be updated to include a new organism option **COVID-19 (SARS-CoV-2)**. The updated option is located in the “**Infection**” section of each of these forms; F2100 R5 (Q429) and F4100 R5 (Q181).

Additionally, the current option value **Coronavirus** will be updated to **Coronavirus (excluding COVID-19 (SARS-CoV-2))**. The additional instructional text was added to further clarify this option should NOT be selected if the organism is COVID-19.

As of March 27th, a COVID-19 diagnosis can immediately be reported on the F2100 and F4100.

TED Track Reporting: Before the new form 2149 is released in April (see below), we will be providing a way to register COVID infections in your transplant recipients, either through ServiceNow or another secure CIBMTR website. More instructions will be provided early next week.

RESPIRATORY VIRUS POST-INFUSION DATA FORM (2149)

In order to collect more detailed data regarding the diagnosis, treatment and outcomes of COVID-19 infections, a new form, Respiratory Virus Post-Infusion Data Form (2149), is anticipated to be released **Friday, April 24th, 2020**.

CRF/CT Track reporting: If **COVID-19 (SARS-CoV-2)** is selected as an organism on the F2100 or F4100 in the “**Infection**” section, this new form will be made ‘DUE’ in FormsNet3.

CRF/CT and TED Track reporting: The form 2149 will also have the option to be created on-demand (on-demand is when a form can be generated by your center at any time). This function is allowed on **BOTH** the **CRF/CT** and **TED** tracks. We are encouraging centers to generate this form on-demand as soon as it is known when a recipient has been diagnosed with COVID-19.

Examples of when to use the on-demand function:

- A recipient is 6 years post-transplant and the next F2100 is not due for 2 more years;

do not wait for the Follow-up form to come due, submit the form as soon as the diagnosis is known.

- Any TED track recipient known to be diagnosed with COVID-19.

Centers will be reimbursed for this form whether the recipient is on the CRF/CT or TED track.

Change effective Friday, April 24th, 2020 (9PM CST)

The Recipient Death Data Form (2900) and the Post-Transplant Essential Data Form (2450) will be updated to include a new option for **COVID-19 (SARS-CoV-2)** as the primary and contributing causes for death.

The blank forms will be made available on the [Data Collection Forms Page](#) of the CIBMTR website prior to Spring Release in April.
