## Original message about upcoming change sent in 9/15/2020 Blast

The CIBMTR is planning to change how consent to the Research Database Protocol is captured, and we want to know your thoughts!

Currently, the Pre-TED (F2400) and CTED (F4000) forms capture if the patient consented to the Research Database, the consent date (if applicable) and the contact status for CIBMTR future research. Typically, these forms are completed after HCT or other Cellular Therapy resulting in the CIBMTR missing the opportunity to contact patients for studies with pre-HCT/CT surveys.

The CIBMTR is proposing to capture the consent information at the time of FormsNet3 patient registration (completion of Form 2804) by utilizing a new consent tool.

We are hosting two sessions to request your input and feedback regarding this new process. We want to understand how these changes will affect your workflow and if there are any unintended negative impacts that should be mitigated.

that time.

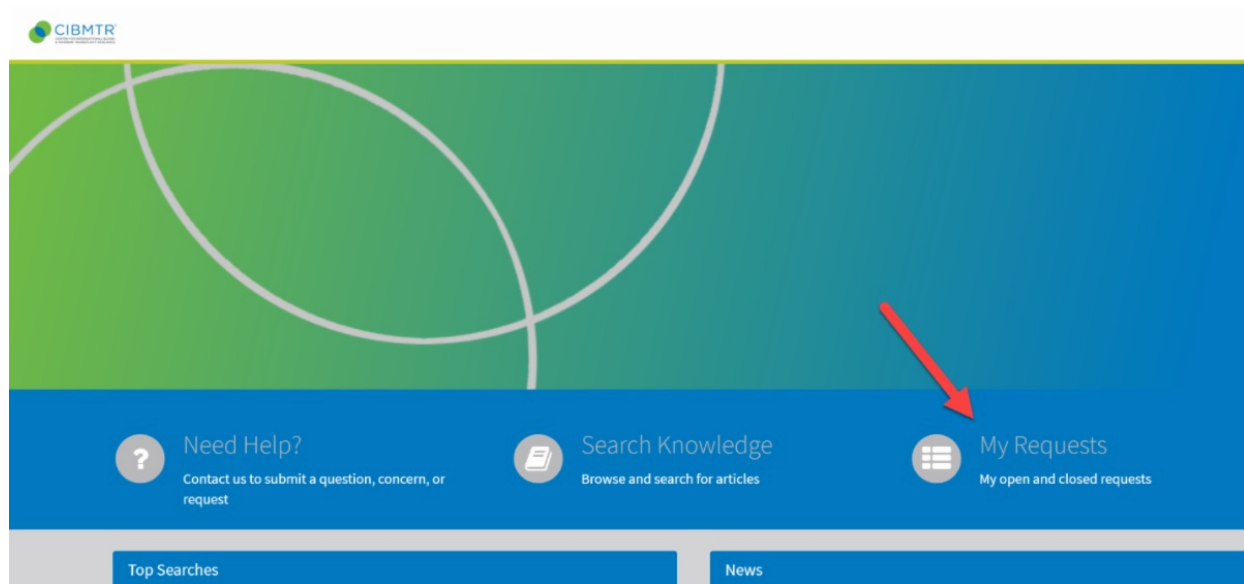
You may still submit a list that was in progress if you've completed it.

### Enhancement to the "My Requests" Dashboard in CIBMTR Center Support

We have had many requests for additional items on the "My Requests" Dashboard to allow centers to search for tickets they have submitted more easily.



As of September 23, 2020, the "My Requests" Dashboard in CIBMTR Center Support is being expanded to include four new items - CRID, Category, Sub-Category and Keep in the Loop. This will make it easier to find the tickets you have submitted and to distinguish between any similar tickets you have.
