## 5. EBMT Centers [table of contents](#)

Together the EBMT and the CIBMTR revised the MED-A and TED forms resulting in two virtually identical forms.

**5.1 EBMT centers submitting data to the CIBMTR as *TED only* centers** (see [section 3.1](#)) **through the EBMT:** Inform the EBMT of your transplant center's agreement to transmit MED-A data to the CIBMTR. Electronic submission of MED-A data from the EBMT will occur several times a year. The CIBMTR will create a Unique ID (CRID) from the EBMT ID number, and use this number to communicate with the EBMT.

**5.2 EBMT centers participating as *Comprehensive Report Forms* centers** (see [section 3.2](#)): If the recipient does not have a previously assigned unique ID, first complete the Unique ID Assignment Form (Form 2804) and submit to the CIBMTR. Then, select one of the following options for form submission:

- Transplant centers wishing to complete both TED level and Comprehensive Report Form data for the CIBMTR should initially complete the Form 2804. Then complete both the Pre-TED and then MED-A. Submit the Pre-TED to the CIBMTR and submit the MED-A to the EBMT. Once the Pre-TED is submitted to the CIBMTR, the follow-up forms will be determined by the CIBMTR form selection algorithm (see [section 3.3](#)). Those centers submitting the Pre-TED directly to the CIBMTR are requested to complete the fields marked as "optional for non-US centers."
- Complete the MED-A, and submit to the EBMT. The EBMT will transmit the data to the CIBMTR. The CIBMTR will then use these data to generate a Unique ID (CRID). The Unique ID (CRID) should be used for this recipient's data submission. The CIBMTR will use the forms selection algorithm to determine the type of follow-up forms that will be required (see [section 3.3](#)).

Recipients selected for the Comprehensive Report Form track will be listed in the Forms Due section of the FormsNet™2 application. Data used to complete the Comprehensive Report Forms should be submitted to the CIBMTR, as the EBMT cannot receive or transmit these data to the CIBMTR.

- Recipients selected for the Comprehensive Report Form track should continue to have MED-A level data submitted to the EBMT, and Comprehensive Report Form data submitted to the CIBMTR. If a recipient is not selected for the Comprehensive Report Form track,

the transplant center should send MED-A data to the EBMT and the CIBMTR will periodically acquire these follow-up data.

**NOTE:**

The EBMT and the CIBMTR are working toward more frequent submission of EBMT data to the CIBMTR, to eliminate future submission of the Pre-TED.

- 5.3 Consent Forms:** All EBMT centers must obtain consent from each recipient participating in the research protocol or repository protocol in a manner consistent with the laws and regulations of their country. The assurance that consent is being obtained will be provided to the CIBMTR through the transplant center's signed Data Transmission Agreement (DTA). Once the DTA has been signed, data submitted through the EBMT (via the Med-A) will be assumed to be compliant with local regulations regarding human subject protection.
